

**Town of New Hope Regular Board Meeting  
Tuesday October 19, 2021 – 7:00 p.m.  
North New Hope Church, 845 County Rd. T N**

Board members present: Chair Todd Knepfel, Timm Raddatz, Dan Zaborowski, Dorene Stolpa - Treasurer, George Guyant - Clerk

**1. Call to order.**

Chairman Knepfel called the meeting to order at 7:00 PM. He opened the meeting leading us in the Pledge of Allegiance.

**2. Review/Approval of minutes.**

The minutes of the September monthly meeting were read by Clerk Guyant. Raddatz moved to approve the minutes as presented, seconded by Zaborowski. Motion carried.

**3. Persons who wish to address the Board.**

Tim Fischer – Wisconsin Rapids – He has a seasonal dwelling on Maple Ridge Rd. and he questions the change to mandatory participation in the town wide garbage and recycling because they would not use the containers or service.

Steve Christian – Neenah – He owns a seasonal dwelling at 966 S Lake Rd. He questioned why the change to town wide garbage and recycling was not publicized more. He feels seasonal dwelling should be able to opt out.

Jan Anderson – New Hope – Currently four families share garbage and recycling service and the change will increase their costs. She feels there should be able to continue to share.

**4. Resolution #21-1 on Ward Division and Designation Poling Place.**

Zaborowski moved to adopt, second by Raddatz. Motion carried.

**5. Resolution #21-2 on Special Charge for Garbage and Recycling Pickup.**

The board discussed the reactions to the town wide garbage and recycling pickup. It was agreed that vacant uninhabitable dwelling will be excluded. Raddatz moved to adopt, Zaborowski second. Motion carried.

**6. Ordinance #21-1 on All-Terrain Vehicles & Routes**

Enforcement concerns were discussed. Zaborowski moved for adoption, Raddatz second. Motion carried

**7. Road Improvement report.**

Chairman Knepfel reported that Glodowski will be installing the culvert on Johnson Rd. at the Nace Creek crossing, correcting beaver damage.

Swenson billed \$15,00.00 for clearing after the July windstorm and they still have work to do on Trout Creek Rd. Glodowski will handle finish clearing Hotvedt Rd.

Clerk Guyant will prepare and distribute a budget worksheet

**9. Payment of bills.**

Supervisor Zaborowski moved to pay the bills totaling \$29,896.33, seconded by Raddatz. Motion carried.
