- 1. <u>Call to order, followed by Pledge of Allegiance</u>. Chair Todd Knepfel called the Annual Town meeting to order at 6:40 pm.
- 2. <u>Review/Approval of Minutes</u>. Prior to the meeting, minutes from the Annual Town Meeting were distributed to the Board via email and were posted on the website. Supervisor Raddatz moved to approve the minutes as written, seconded by Supervisor Reser. Motion carried.
- 3. <u>Persons who wish to address the Board</u>. Laurie Stoltenberg presented a new handout for a 20 x 24 addition to the existing Town Hall. A lively discussion ensued. Several residents expressed a concern that the cost was underestimated, especially with current tariffs. Chair Knepfel thanked Ms. Stoltenberg for her significant efforts.
 - The Board asked that New Hope Residents be sent a postcard with a request for any firm written offers for the building located at 9485 Town Hall to be submitted to the town clerk prior to the next meeting. That mailing should be completed by the end of April.
- 4. <u>Spring Election (Tuesday, April 1, 2025)</u>. There were 321 electors participating in the Spring 2025 election. All incumbent board members, treasurer, and clerk were re-elected. The next election will be in spring 2026.
- 5. <u>Road Report</u>. Ongoing brushing is restricted by oak trees. Road repair will be triaged after the completion of the Annual Road Survey (scheduled for April 18-19).
 - a. <u>Annual Road Survey</u>. The Board will complete its annual road survey on April 18-19. The results will be reported on the State's DOT WISLR site.
