- 1. <u>Call to order, followed by Pledge of Allegiance</u>. The Regular October Town Board Meeting was called to order by Chair Knepfel at 6:00 pm.
- Review/Approval of Minutes from September 15 and October 9, 2025. Prior to the meeting, minutes from the September Regular Town Board Meeting and the 2026 Budget Workshop were circulated to the Board via email, and posted as drafts on the town website. Reser moved to accept both sets of minutes as written, seconded by Raddatz. Motion carried, 3-0. Approved minutes will be posted on the town website.

- 4. <u>Town Hall</u>. No report. This item will remain on the agenda until resolved.
- 5. <u>Sunset Lake Association: No DNR grant applied for in 2025</u> (see email in packet). Per an email from Pat Quigley, the Sunset Lake Association will not apply in 2025 for a DNR milfoil control grant.
- 6. **Road Improvement report**. Swenson completed roadside brush cleanup. No further road repair or brushing work is planned for 2025. Trees overhanging a northern segment of Sunset Lake Road will be trimmed back for safe bus passage in early 2026.
- 7. **2026 Town Budget**. A preliminary budget for 2026 was developed at the October Workshop, and will be finalized at the next workshop. A Public Hearing and Meeting of Town Electors in November will be held to approve the budget.
- **8.** <u>New Business/Announcements</u>. An updated list of New Hope residents receiving trash service will be submitted to Harter's in December.
- 9. <u>Payment of bills</u>. Raddatz moved to pay the October bills totaling \$30,645.04, seconded by Reser. Motion carried, 3-0.
